Subject: Item No. 3.803.2 Amendment in the de-affiliation procedure of ITIs/ITCs Sir/Madam,

This is to inform you that the 38th meeting of the National Council for Vocational Training (NCVT) under the Chairmanship Hon'ble Minister for Labour & Employment, was held on 31st May,2010.

The Council recommended following amendment in the existing procedure for de-affiliation, mentioned in **appendix -XX** of the Training Manual for Industrial Training and Centers.

- I. Whenever, Secretary NCVT finds it necessary to carryout evaluation of any ITI/ITC, Secretary NCVT shall request the concerned State Director to constitute a Committee and to carry out inspection for evaluation within a period of 6 weeks. In case, State Director fails to constitute such committee and facilitate inspection of institute within stipulated time period, such committee would be constituted by Secretary NCVT which would carry out necessary evaluation.
- II. The Standing Committee for evaluation should submit its report to DGE&T/Secretary (NCVT) within 07 days of the inspection. The recommendation of the committee would be placed before sub-committee of NCVT dealing with affiliation for consideration and decision.
- III. In cases where, Standing Committee for Evaluation could not carry out inspection of institute for reason due to closer of the institute or other wise, the Evaluation Committee will submit the facts to the NCVT and the institute would be considered for de-affiliation/ suspension of affiliation from NCVT by the sub-committee of NCVT dealing with affiliation on the basis of the report.
 - 3. The Government of India has accepted the above recommendations of the Council for implementation with immediate effect. Accordingly, the existing guidelines for de-affiliation of ITIs/ITCs from NCVT has been revised and are given in **annex**. Henceforth, above guide lines would be followed while de-affiliation of ITIs/ITCs from NCVT.

APPENDIX XX of Training Manual

Procedure for Evaluation of ITIs/ITCs/Trades/Units which are already Affiliated to NCVT (Government and Private) – De-affiliation Procedure

Under the Craftsmen Training Scheme of Government of India , Ministry of Labour prescribed affiliation procedure is followed for granting affiliation to the trades/units which are found up to norms/standards prescribed by NCVT. With the objective of maintaining quality of training at a national level, it is desirable to ensure that such institutes /trades/units which enjoy national status (affiliation to NCVT) continue to maintain the prescribed norms and standards. It is quite possible that an institute/trade/unit in due course of time may fail to maintain the prescribed orms/standards due to negligence of the management. As already contained in the Training Manual, it is desirable that in such a case the institute/trade/unit is evaluated and if facilities are found inadequate, affiliation already granted should be withdrawn. In this regard no procedure has been prescribed so far. Therefore the following procedure is laid down which should be followed for evaluation of the trades / units at an ITI (Government / Private) which are already affiliated to NCVT.

- 1. A notice should be issued to the management of ITIs/ITCs for evaluation of their institutes as per Annexure I to this procedure.
- 2. Periodical inspections as envisaged in the Training Manual, should be conducted by the respective State Directorates/UT Administrations and RDATs under DGET, Ministry of Labour. If infrastructural facilities in respect of a trade / unit (already affiliated to NCVT) at an institute (Government / Private) are found to be below the prescribed norms / standards and inadequate, it should be reported to the concerned State Director / UT Administrator by the inspecting officer / team, forwarding the relevant inspection report and highlighting the details of deficiencies / discrepancies observed during the inspection.
- 3. Either on the basis of inspections as stated at para 2 above or otherwise when it comes to the notice/knowledge of the concerned State Director (dealing with Craftsmen Training Scheme)that a particular ITI/ITC, in specific trades/units is either not conducting training as per curriculum and/or is lacking in maintaining the norms/standards prescribed by NCVT, he may initiate action and constitute Standing Committee for evaluation of the institute under intimation to the Director of Training, DGET, Ministry of Labour.

Similarly when it comes to the notice/knowledge of the Directorate General of Employment and Training, Ministry of Labour, the Director of Training (Secretary NCVT) may inform the concerned State Director and request him to constitute a Standing Committee for evaluation and get the institute/trade/unit inspected.

- 4. The Standing Committee for evaluation shall be constituted by the concerned State Director/UT Administrator or the same lines as is done for considering affiliation. The composition of above committee shall be as under:
- 1. *One member to be nominated by the Secretary of the NCVT/ or his/her representative Chairperson.
- 2. *One member to be nominated by State Director in-charge of Craftsmen Training member.

- 3. **Two members to be nominated by SCVT (one technical expert from Industry and other the technical expert representing a trade union) member.
- 4. The State Director may co-opt one/two experts in the relevant trade/ trades.
- (a)*Representatives from Govt. Departments should be a Group 'B' Gazetted (technical) officer or above; and
- (b)**Representatives from trade union should be responsible office bearer and from Industry, should be of the rank of Deputy/Assistant Manager depending on whether it is medium scale/large scale industry.

Note: No two members should be from same department.

NOTE: At least three members (one representative of the Secretary NCVT, one representative of the State Directorate and anyone other) will form quorum.

- 5. As stated at (3) and (4) above, the Standing Committee for evaluation shall be constituted by the concerned State Director and necessary arrangements for inspections of ITIs/ITCs shall be made by him. A notice should be issued to the management of the ITI/ITC for inspection of the institute by the Standing Committee as per Annexure II to this procedure. The standing committee shall inspect the Institute and verify the existing infrastructural facilities, viz. Staff accommodation, workshop buildings, tools, shop outfits, equipment etc. as per prescribed norms/standards and conduct of training in relevant trades/units.
- 6. The committee shall prepare their report, the same day on the same proforma which has been prescribed for considering affiliation. Deficiencies/discrepancies observed at institute should be clearly mentioned in the appropriate columns of the proforma. The committee shall make their specific recommendations on the following lines:

recommended for continuance of affiliation. The management of the institute should be informed of the minor deficiencies/discrepancies observed at the institutes for taking expeditious action to make them up within a stipulated period.

Recommended for de-affiliation i.e. withdrawal of affiliation granted to them,

- 7. Five copies of the report should be taken by the representative of the State Director and one copy should be collected by the representative of the secretary, NCVT. Subsequently, 4 copies of the inspection report should be forwarded by the concerned State Director to DGET Headquarters if de-affiliation or withdrawal of affiliation has been recommended by the committee for certain trades/units.
- 8. The Inspection report should be scrutinized in the Directorate General of Employment and Training. After scrutiny of the report if Secretary, NCVT thereon, should be forwarded to the members of the sub-committee of NCVT dealing with affiliation for their consideration and approval.

- 9. After obtaining due approval of the members of the subcommittee, de-affiliation order shall be issued to the concerned State Director with a copy to the concerned Institute. On the basis of this order, in the case of a private institute, the State Director should issue de-affiliation order to the Management of the Institute. In case of a Government Institute, similar appropriate action shall be taken by State Director.
- 10. From the date of the issue of such an order by the State Director the relevant trades/units will stand de-affiliated. However, the existing batch of trainees if otherwise eligible should be permitted by the state Director to appear in the ensuing All India Trade Test. Further admission of trainees should be stopped from the next session onwards.
- 11. When deficiencies/discrepancies are made up, the institute/trade/unit can be re-started by the management in accordance with the existing affiliation procedure.
- 12. Whenever, Secretary NCVT finds it necessary to carryout evaluation of any ITI/ITC, Secretary NCVT shall request the concerned State Director to constitute a Committee and to carry out inspection for evaluation within a period of 6 weeks. In case, State Director fails to constitute such committee and facilitate inspection of institute within stipulated time period, such committee would be constituted by Secretary NCVT which would carry out necessary evaluation.
- 13. The Standing Committee for evaluation should submit its report to DGE&T/Secretary (NCVT) within 07 days of the inspection. The recommendation of the committee would be placed before sub-committee of NCVT dealing with affiliation for consideration and decision.
- 14. In case where, the institute listed for inspection for evaluation, found closed by the Standing Committee for evaluation on the scheduled date of inspection, the Evaluation Committee will submit the facts to the NCVT and the institute would be considered for de-affiliation/ suspension of affiliation from NCVT by the sub-committee of NCVT dealing with affiliation on the basis of the report.

You are supposed to provide and maintain infrasturural facilities and conduct training as per prescribed norms/standards in these trades/units for continuance of affiliation. As and when considered desirable your institute may be inspected by standing committee, constituted by the State Director as per prescribed procedure to ensure that all the training facilities are being provided continuously. You should render necessary cooperation and assistance to committee for inspecting the institute/trades/units.

You are hereby informed that if infrastructural facilities are not found adequate as per norms/standards, the trades/units already affiliated to NCVT may be de-affiliated in accordance with prescribed procedure. You are also informed that if Standing Committee is not allowed to inspect the institute or necessary cooperation is not rendered for inspection, it may be viewed seriously by the State Government.

The above notice is to be issued through registered post to the management of all the ITIs/ITCs by the concerned State Director/UT Administrators once in every year in the month of January/February.

It has come to our notice that your institute does not maintain infrastructural facilities as per prescribed norms/standards in the trades/units which have already been granted affiliation to NCVT. Therefore it has been decided to get your institute inspected on........................(date) by Standing Committee constituted to ascertain availability of infrastructural facilities therein. You are hereby informed that if facilities provided and training imparted in the affiliated trades/units are not found adequate as per prescribed norms/standards, these trades/units may be de-affiliated in accordance with the prescribed procedure for evaluation.

You are requested that all necessary assistance and cooperation is extended to the Committee for inspecting the ITIs/ITCs/Trades/Units on the fixed date. It is informed that if the Standing Committee is not allowed to inspect the institute or necessary cooperation is not extended to the committee, it may be viewed seriously by the State Govt."

The above notice is to be issued by the concerned State Director/UT Administrator to the management of the ITI/ITC through registered post at least 30 days before the date of inspection.

Item No. 3804.3: Abolition of provision for 3 months POT modules for instructors having 5 years and more experience as on July,2004 to designate them as trained instructors for trades where instructor training facilities are available.

Sir,

I am directed to inform you that the 38th meeting of the National Council for Vocational Training (NCVT) under the Chairmanship Hon'ble Minister of Labour & Employment, was held on 31st May,2010. Abolition of provision for 3 months POT modules for instructors having 5 years and more experience as on July,2004 to designate them as trained instructors was discussed in the meeting vide item No.3804.3 of agenda.

It was experienced that provision for POT training of 3 months duration for instructors having 5 years and more experience as on July, 2004, as one time relaxation, made vide letter No. DGE&T 19(2)/2004-CD dated 19th/22nd July,2004 was affecting badly the quality of delivery of training. Therefore, the Council recommended to abolish the above provision with immediate effect. The council also deliberated on various issues relating to quality of trainers of ITIs/ITCs and approved the following for implementation with immediate effect:

- 1. Withdrawal of orders issued vide letter No. DGE&T 19(2)/2004-CD dated 19th/22nd July,2004 regarding special provision of 3 month POT training for instructors having 5 years and more experience as on July, 2004 and giving them status of trained instructors.
- 2. DGE&T shall prepare a proper scheme/ plan for the training of untrained instructor based on requirement on number of untrained instructor provided by respective State Govts.
- 3. All the existing instructors should be trained in all the modules with in a period of three years. Trades where DGE&T have insufficient/no capacity, possibility will be explored to larrange training in modules with the help of appropriate institutes in the public / private sector having such competency.
- 4. After a period of three years, any institute desirous of getting affiliation for new/additional trades/units, has to be ensured that there should not be any untrained instructors for already affiliated trades/units in that institutes.
- 5. All the instructors must attend 2 week refresher training programme every alternate year arranged by DGE&T / State Directorate/ IMCs. TA/DA for these programme will not be necessarily be paid by DGE&T.
- 6. Vocational Instructors of ITIs/ITCs should be promoted to higher post only after they posses Craft Instructor Certificate.

Contd..

Government of India has accepted the above recommendation of the council for implementation with immediate effect. Accordingly, following norms should be followed with immediate effect

- 1. Henceforth instructors would not be given the status of trained instructor in accordance with order issued vide letter No. DGE&T 19(2)/2004-CD dated 19th/22nd July,2004.
- The instructors must be trained in all the modules as per NCVT norms and must posses National Craft Instructors Certificate to give them the status of trained instructors.
- 3. Vocational Instructors of ITIs/ITCs should be promoted to higher post only after they posses National Craft Instructors Certificate.
- 4. In order to ensure that training is delivered only by trained instructor, ITIs/ITCs/ any other institute affiliated to NCVT must depute 20-30% instructors every year for "Training of Trainers Programme" so that all the existing instructors are trained during a period of three years and. Thereafter, NCVT affiliation for new/additional trades/units in any ITI/ITCs would be granted only after ensuring that there are no untrained instructors for already affiliated trades/units in that ITIs/ITCs.

Subject: Appointment of two Instructors for two units of each trade with different qualifications

Sir.

Your kind attention is invited to our earlier letter of even No. dated 6th August, 2010 on the above subject where in it was informed that institutes (ITIs/ITCs) desirous of taking affiliation from NCVT must apply for a minimum of two units (or multiple of two units) of a trade at a time and appoint two instructors one for each unit, as per norms. Out of these two instructors, one instructor must be with Diploma/Degree in relevant branch of engineering from recognized board/university and experience prescribed by NCVT.

It has been brought to our notice that the above instruction is not clear about the appointment of instructors in the trades in which, one unit is already running in the it is/ITCs and it they apply for the other unit of same trade. In this regard following is informed:

- If the institute has odd number of affiliated trade units, it can apply for one unit to j) make it even. Subsequently the institute would apply for even units for affiliation.
- ii) Qualification of the instructors should be such that for every two units one instructors should be with Diploma/Degree in relevant branch of engineering from recognized board/university and experience prescribed by NCVT.

Sir/Madam.

I am directed to inform you that the 38th meeting of the National Council for Vocational Training (NCVT) under the Chairmanship Hon'ble Minister of Labour & Employment was held on 31st May,2010 was discussed vide item No.3804.10 of agenda.

Keeping in view the escalating cost of land, and non availability of required land in urban areas, metropolitan and other cities, the council deliberated and approved vertical expansion, with multi storied design for workshop with a condition that trades with heavy machineries to be housed only in the ground floor and remaining trades may be housed at any floor. Further, before housing any trade involving machineries at any floor other than ground floor, a certificate regarding safety/suitability of structure to house that trade from Civil/Structural Engineer would be necessary. It was also approved that as per building bye laws, buildings having more than three floors, provision of lift would be mandatory.

Government of India has accepted the above recommendation of council for implementation with immediate effect. Accordingly, Workshop of following trades requiring heavy machinery must be accommodated on ground floor.

Welder, Foundryman, Mechanic Tractor, Mechanic Diesel, Mechanic Motor Vehicle, Fitter, Turner, Machinist, Sheet Metal Worker, Carpenter, Machinist Grinder, Tool and Die Maker, Building Constructor(Mason) & any other having single machinery weighing more than 200 Kg. Remaining trades may be housed at any floor. However, as per building bye laws, buildings having more than three floors, provision of lift is mandatory

- 3. **Two members to be nominated by SCVT (one technical expert from Industry and other the technical expert representing a trade union) member.
- 4. The State Director may co-opt one/two experts in the relevant trade/ trades.
- (a)*Representatives from Govt. Departments should be a Group 'B' Gazetted (technical) officer or above; and
- (b)**Representatives from trade union should be responsible office bearer and from Industry, should be of the rank of Deputy/Assistant Manager depending on whether it is medium scale/large scale industry.

Note: No two members should be from same department.

It is requested that above composition of Standing Committee for inspection of ITIs/ITCs for affiliation purpose should be strictly followed while its constitution by respective state governments.

As computer literacy is demand of labour market, it was proposed to make IT literacy course compulsory for the trainees of ITIs/ ITCs. The issue was deliberated and the council approved to make the IT literacy course compulsory for all the training schemes of DGE&T. The council also approved the following guide lines in this regard:

- 1. DOEACC be approved as one of the assessing and certification bodies for assessment of trainees. Any similar institution set up by the State Govt. for certification can also be designated for certification, by respective State Directorates
- 2. NTC shall be issued only after passing this IT literacy course.
- 3. This decision will be effective from session starting from August, 2011.
- 4. The DOEACC would develop study material and e-learning package for mass scale training in the course. It would be available on internet free of cost.
- 5. The existing infrastructure of ITIs can be used to implement this training programme.
- 6. The responsibility of training would rest with the institute/centre.
- 7. DOEACC would decide the fee charged (if any) in consultation with DGE&T and concerned State Governments.

Government of India has accepted the above recommendation of council for implementation from session starting from August, 2011. Thereafter, IT literacy will be made a compulsory course for trainees under going training in ITI/ITCs under Craftsmen Training Scheme. A curriculum on Basic Computer Course has been prepared by DOEACC and the copy is enclosed for ready reference. The same is also available on website of DGE&T and DOEACC.

In view of above, you are requested to initiate action for introduction of IT literacy programme in ITIs/ITCs in your state as per the approved curricula. The existing infrastructure of ITIs can be used to implement this training programme. DOEACC has been approved as one of the assessing and certification bodies for the purpose. Any similar institution /organization set up by State Government for certification can also be designated for training and certification only with approval from NCVT. The fee charged by DOEACC/ any other agencies should be decide in consultation with DGE&T concerned State Governments.

Subject: Item No. 3804.13: Redefining the norms for appearing in All India Trade Test as Private Candidates

Sir/Madam.

I am directed to inform you that the 38th meeting of the National Council for Vocational Training (NCVT) under the Chairmanship Honble Minister of Labour & Employment was held on 31st May,2010. Redefining the norms for appearing in All India Trade Test as Private Candidates was discussed vide item No.3804.13 of agenda.

The council approved following amendment in the norms for appearing in All India Trade Test as Private Candidates, all other existing provisions remained unaltered:-

- 1. The applicant should possess minimum of 3 years experience instead of 5 years in the relevant trade in establishments implementing Apprenticeship Training Scheme/ small establishments and shops covered under Factory Act or Registered with any Government/ local authorities.
- 2. SCVT Certificate holders who has received institutional training in same trade with same duration of training period & entry qualification.

The council also approved that wherever private candidates are allowed, the examinations shall be supervised by Tripartite Board consisting of representatives from Employers, trade unions and the Government. Secretary SCVT would constitute trade wise tripartite board and notify such centres where private applicants should submit the applications. Secretary SCVT should notify exclusive centers for examination of private candidates.

Government of India has accepted the above recommendation of council with Immediate effect. Henceforth, "All India Trade Test" for private candidates should be supervised by Tripartite Board consisting of trade representatives from Employers, trade unions and the Government. Secretary SCVT should constitute trade wise tripartite board and notify such centres where private applicants should submit the applications. Secretary SCVT should also notify exclusive centers for examination of private candidates.

Revised norms for appearing in All India Trade Test as private candidate are given below. These norms should be followed with immediate effect.

- i) The applicant should have the minimum prescribed entry qualification for a particular trade under CTS in which he/she is desirous of appearing as private candidate.
- ii) The applicant should possess minimum of 3 years experience in the relevant trade in establishments implementing Apprenticeship Training Scheme/ small establishments covered under Factories Act, 1948 or Registered with any government/ local authorities.
- iii) SCVT Certificate holders who has received institutional training in same trade with same duration of training period & entry qualification.
- iv) There should be trade test by SCVT for all the candidates who are desirous of appearing in the All India trade test under the aegis of NCVT as private candidates. All those, who qualify the SCVT test, may be permitted by the State Director to appear in the AlTT under NCVT.
- v) Private candidates from establishments covered under the Apprentices Act, 1961 and sponsored candidates of ITIs and SCVT certificate holders (above iii) may be exempted from appearing in the trade test to be conducted by the SCVT.
- vi) Apprentices under the Apprentices Act, 1961 who have failed six times in the All India Trade Tests for Apprenticeship can appear as private candidates in the corresponding ITI trade only. This will be only applicable to such apprentices who have not qualified earlier for the award of National Trade Certificate by the NCVT.

I am directed to inform you that the 38th meeting of the National Council for Vocational Training (NCVT) was held on 31st May,2010 under the Chairmanship Hon'ble Minister of Labour & Employment. Issue of computerized certificate to AITT passed candidates was discussed vide item No.3804.16 of agenda.

It was proposed that using ICT, the National Trade Certificate would be printed at DGE&T and supplied to State Directors so that delay in distribution of certificates could be avoided. The council approved the above proposal for issue of computerised certificates to pass out trainees of AITT. The council also approved the following guidelines

- Admissions in ITIs/ITCs should be closed by State Directorates by a fixed date for both the sessions i.e. 28th/29th February and 31st August respectively for August and February session. The admission details in a prescribed proforma should be forwarded to DGE&T in a soft copy in CD or DVD within one month from the closing date of admission i.e. by 31st March and 30th September for both the session. There should be only one CD/ DVD for whole State.
- After the exams are conducted and results are declared, State Govt. should again forward a
 copy of result updating exactly in the same table in which data was sent earlier. The DGE&T
 will print the certificates name-wise (of students) and forward it to State Directorates with
 printed signature of NCVT Secretary. The Secretary SCVT will countersign the certificates
 before distribution to students. In this way trainees may get certificate with in six month.

Government of India has accepted the above recommendation of council for implementation with immediate effect. Henceforth, All the state governments are required to submit the admission details in a prescribed proforma to DGE&T in a soft copy in CD or DVD within one month from the closing date of admission i.e. by 31st March and 30th September for February for August and session respectively. There should be only one CD/ DVD for whole State(institute wise should not be forwarded).

Also, State Govt. should again forward a copy of result updating exactly in the same table in which data was sent earlier. The DGE&T will print the certificates name-wise (of students) and forward it to State Directorates having printed signature of Secretary NCVT. The Secretary, SCVT would counter sign the certificate before distribution to trainees. DGE&T would discontinue supply of blank National Trade Certificate to State Government.

- ii) For ITI / ITC having less than 8 units, practical trade test may be conducted in an affiliated ITI/ITC having minimum 8 units capacity and relevant trade(s) which is located preferably within a distance of 50 kms.
- For ITIs having less than 8 units capacity, the theoretical test may be conducted after grouping different small ITIs in a suitable building if so required.
- The State Director in-charge of Craftsmen Training should ensure that the trade testing centres located by them have all the requisite facilities in terms of tools, equipment and machinery for conducting the practical tests. They should also depute responsible officer to visit these centres prior to commencement of the trade test to ensure that the required number of machines/equipment are in order at these centres. The institutes where the required number of machines/equipment/tools are not available or are not in a working condition, should not be selected as a trade testing centre.
