This is to inform you that the 39th meeting of the National Council for Vocational Training (NCVT) under the Chairmanship Hon'ble Minister of Labour & Employment was held on 12th January, 2011. Uniformity in nomenclature of Training Institutes was discussed in the meeting vide agenda item no.3903.4, that as per existing system, the Government institutes set up by respective State Government are named as Industrial Training Institutes (ITIs) and those set up by private entrepreneurs/ management are named as Industrial Training Centres (ITCs). As both the ITIs and ITCs are conducting same training programmes, students undergo the same examination and certification; therefore it was proposed that Industrial Training Institutes (ITIs) and Industrial Training Centres (ITCs) may be uniformly known as Industrial Training Institutes (ITIs). The Council approved the proposal that Industrial Training Institutes (ITIs) and Industrial Training Centres (ITCs) may be uniformly known as Industrial Training Institutes (ITIs) while adding "Government" or "Private" word as the case be.

Government of India has accepted the above recommendation of council for implementation. Henceforth, Industrial Training Institutes (ITIs) and Industrial Training Centres (ITCs) may be uniformly known as Industrial Training Institutes (ITIs) while prefixing words either "Government" or "Private" as the case may be as under:-

"XXXX(Name of Institute) XXXX Government Industrial Training Institute" "XXXX(Name of Institute) XXXX Private Industrial Training Institute".

Accordingly, all the state Governments are requested to ensure changes in nomenclature of institutes within next six months. State Governments may also like to publish the change in nomenclature in local news papers in regional languages, for public awareness.

The council also recommended that trades having demand but requiring large investment should be clearly identified to avoid any ambiguity.

After discussion the council approved the above proposal. Government of India has accepted the above recommendation of council for implementation with immediate effect. Accordingly, State Governments are requested to give priority to the trades having demand but requiring large investment while formulating proposal to open new ITI or adding new trade in existing ITIs: List of existing trades under CTS involving high investments is annexed.

Subject: Permission for Special Purpose Vehicles (SPV) or similar arrangements to set up ITIs as per NCVT norms in high investment and technically diverse sectors.

Sir/Madam,

This is to inform that 39th meeting of the National Council for Vocational Training (NCVT) under the Chairmanship Hon'ble Minster of Labour & Employment was held on 12th January, 2011 Special Purpose Vehicles (SPV) or similar arrangement may also be permitted to set up trade units/ITIs in high investment or technically diverse sectors to meet the skilled manpower in such sector was discussed in the meeting vide item no. 3903.7 of agenda.

At present ITIs have not been set up to meet the skilled man power demand of the sectors which are technically diverse and require high investment viz. Aviation, Petroleum & Natural Gas, Metallurgy, Power etc. These sectors are now expanding and there is growing demand of trained man power, in these sectors. The skill training requirements of the sectors are capital intensive which inhibits an organization to create training facilities at one place. For example H.T. Sub Station, Long distance pipe lines etc. As training needs in these sectors are diversified, therefore, it may take place at different locations as per work requirement. Creating infrastructure for imparting training of these sectors would demand huge investment and some time it is even not possible to create such infrastructure at institute to address this issue active help of industries of these sectors having adequate infrastructure and sufficient technical expertise could be utilized for imparting training by creating subject purpose vehicles or similar arrangements. It was, therefore, proposed that special purpose vehicles or similar arrangement may be permitted to set up ITIs in such sectors. After discussion the Council approved the above proposals.

Government of India has accepted the above recommendation of council for implementation with immediate effect. Henceforth, Special Purpose Vehicles (SPV) or similar arrangements are permitted to set up trade units/ITIs in high investment or technically diverse sectors to meet the skilled manpower requirements in such sectors after taking necessary approval from NCVT as per norms.

Sir/Madam,

This is to inform you that 39th meeting of the National Council for Vocational Training (NCVT) was held on 12th January, 2011 under the Chairmanship Hon'ble Minister of Labour & Employment. Payment of salary to vocational instructors of ITI/ITCs (regular/ contract basis) through banks only was discussed in the meeting vide agenda item No. 3903.8.

It was brought to the notice of DGE&T that some of the ITIs/ITCs are paying very meager salary to instructors appointed on contract basis. As a result, good quality instructors were not attracted to these jobs. Therefore, to bring further transparency and uniformity in the system, it was proposed that all the instructors (regular/contract basis) engaged in ITIs/ITCs should be paid their remunerations only through Banks/Post offices. This system would ensure that recommended salaries are paid to these instructors regularly and also on time.

Government of India has accepted the above recommendation of council for implementation with immediate effect. Henceforth, salary / remunerations to instructors (regular/contract basis) engaged in Government & Private ITIs (earlier known as ITIs/ITCs) shall be paid only through Banks/Post offices. All States/ UT Governments are requested to ensure that above mode of payment of salary/ remunerations to instructors (regular/contract basis) are strictly followed by all the Government and Private ITIs of their respective State.

Sir.

I am directed to inform you that the 39th meeting of the National Council for Vocational Training (NCVT) under the Chairmanship of Hon'ble Minister of Labour & Employment was held on 12th January, 2011. Guidelines for setting up of Institute for Training of Trainers and conducting the Training Programmes under Craft Instructor Training Scheme (CITS) were discussed in the meeting agenda Item No.3903.9.

- 2. NCVT during its 38th meeting had approved setting up of the Instructor Training Institutes by State/UT Governments, companies like sole propriety, private/public limited registered under Companies Act, Societies and Trusts registered as per Act, and promoters of SEZs. In order to maintain quality and standards of instructor training in all such institutes, it was decided that such institutes should be affiliated to NCVT so that the trainees after completion of training are trade tested and successful trainees could be awarded Craft Instructor Certificates under the aegis of NCVT.
- 3. Accordingly, complete Guidelines for setting up of Institute for Training of Trainers (ITOT) under "Craft Instructor Training Scheme" including norms/standards for infrastructure, building (workshop, class-room) electricity, machinery, equipment, tool & implements, human resource (including levels of Principal, Trainers), composition of Standing Committee for carrying out inspection were approved by the NCVT during its 39th meeting. Also admission guidelines including eligibility, reservation, suitability of trades for persons with special abilities, trade testing procedure, distribution of marks, and format for mark-sheet were also approved by the NCVT for implementation. It has also been decided that such institutes be named as Institute for Training of Trainers (ITOT).

- 4. Government of India has accepted the name "Institute for Training of Trainers (ITOT)" and guidelines for setting up of such institutes. These are to be implemented with immediate effect. Henceforth, any agency whether Government or Private, desirous of setting up Institute for Training of Trainers (ITOT) is required to follow these guidelines (copy enclosed) while setting up such Institute and conducting courses under Craft Instructor Training Scheme (CITS) in these institutes. These guidelines are also available at DGE&T website www.dget.nic.in.
- 5. DGE&T would extend help and guidance to the organisations including State Govts, desirous of setting up of "Institute for Training of Trainers (ITOT)", in case necessity arises, mentors will be provided to render assistance for setting up of such institutes.

This is to inform you that the 39th meeting of the National Council for Vocational Training (NCVT) under the Chairmanship Hon'ble Minister of Labour & Employment was held on 12th January, 2011. In order to meet the demand of training of trainers, innovative approaches like adoption of E- Learning and Web-based learning technologies for Instructor Training was discussed vide agenda item no.. 3903.10 in the meeting. Such approach would also help in raising the capacity of the system . extensively in a limited period.

After discussion council approved the proposal for use of E- Learning and Webbased learning technologies for Instructor Training Programmes of DGE&T. The council also approved that that existing modular curricula of instructor training be studied and each module be divided in two parts, one theoretical and other dealing with practical and demonstrations. The theoretical part may be delivered and tested by using elearning and web-based learning technologies. The practical and demonstration part can be covered in training institutes. The trainees, who cannot learn by using eleaning/web-based learning, can attend whole module in ATIs/CTIs/affiliated Institutes for Training of Trainers.

Government of India has accepted the above recommendation of council for implementation with immediate effect. Accordingly, strategy has to be formulated for adoption of E- Learning and Web-based learning Technologies for Instructor Training curses being offered through DGE&T Institutes. In view of above it has been decided that existing course content of the trades under Modular Craft Instructor Training Programme be studied and be divided in two group one purely theoretical and other dealing with practical & its related theory. The training in theoretical part may be imparted using E- Learning and Web-based learning Technologies. The practical and related theory may be imparted in DGE&T institutes.

It was opined that SCVTs as registered Societies will have the advantage in their functioning and decision making since registered society will have minimum activities (regular meetings & discussions, audit etc.) which would be assured every year. These societies would also be required to maintain separate Web-site and Bank Account which should be audited regularly

After elaborate discussion the council approved the above proposal. Government of India has accepted the above recommendation of council for implementation with immediate effect. Accordingly, State Governments are requested to ensure that SCVTs are registered as Societies in the respective State, with separate Web-site and Bank Account which should be audited regularly.

The proposal regarding need for skill mapping by respective State Government was discussed in the meeting vides item no. 3903.13 of agenda.

As the present the labour market is facing a situation, where on the one hand, an employer does not get manpower with requisite skills and on the other, millions of job seekers do not get employment. Therefore, to facilitate matching demand and supply, it was proposed that skill mapping be carried out by respective state starting from district level and only those trades are promoted for introduction of training programme in Government and Private ITIs, which have high demand. After discussion the Council approved the above proposals.

Government of India has accepted the above recommendation of council for implementation with immediate effect. Accordingly, State Governments are requested to initiate skill mapping of their respective states, starting from district level and recommendation of survey report should form basis while selecting new trades for introduction of training programme in Government and Private ITIs.
