अति-आवश्यक सूचना

NCVT परीक्षा जून/जुलाई 2019 (वार्षिक पद्धति व सेमेस्टर प्रणाली) हेतु DGT MIS Portal से जारी होने वाले परीक्षार्थियों के Hall Ticket पर DGT नई दिल्ली द्वारा पूर्व में जारी परीक्षा कार्यक्रम अनुसार परीक्षा तिथि अंकित होकर छात्रों/संस्थानों को प्राप्त हो रहे हैं।

उल्लेखनीय है कि DGT नई दिल्ली द्वारा पत्र क्रमांक MSDE- 18011/08/CTS/June-19/2019-TTC दिनांक 31.05.2019 द्वारा जो नया संशोधित परीक्षा कार्यक्रम जारी किया गया था, उसमें भी पूर्व परीक्षा तिथियों के सामने ही नई तिथिया दर्शायी गई है तथा Hall Ticket पर अंकित पुरानी तिथियों के सम्बन्ध में DGT नई दिल्ली द्वारा अपने उक्त पत्र के पैरा संख्या 04 के अनुसार अवगत कराया गया है कि समय अभाव के कारण उक्त परीक्षा हेतु जारी Hall Ticket पर पूर्व परीक्षा कार्यक्रम अनुसार अंकित परीक्षा तिथि में संशोधन किया जाना सम्भव नहीं है। अतः Hall Ticket पर अंकित पुरानी तिथि को नये संशोधित परीक्षा कार्यक्रम में अंकित तिथियों के अनुसार Hall Ticket मान्य होगा।

अतः उक्त निर्देशों के क्रम में सभी राजकीय एवं निजी संस्थानों/परीक्षा केन्द्रों आदि को सूचित किया जाता है कि उक्त परीक्षा हेतु जारी Hall Ticket पर पूर्व परीक्षा कार्यक्रम अनुसार अंकित परीक्षा तिथि को नये संशोधित परीक्षा कार्यक्रम में अंकित नई तिथि के अनुसार समझा जावे तथा DGT नई दिल्ली के उक्त पत्र (प्रति संलग्न) में दिये गये निर्देशों के अनुरूप परीक्षार्थियों को Hall Ticket जारी करें एवं परीक्षा में सम्मिलित कराना सुनिश्चित करें। सुलभ संदर्भ हेतु संशोधित परीक्षा कार्यक्रम एवं उपरोक्त पत्र संलग्न है।

Subject:- Postponement of AITT under CTS, June / July' 2019 in compliance of Hon'ble High Court of Kerala order dated 10.05.2019 in W.P.(c) 13450 of 2019- regarding.

Sir,

As you are aware that the AITT under CTS for trainees admitted in Gov./Pvt. ITIs is scheduled to be held from 10.06.2019 to 02.07.2019. The Kerala Pvt. ITI Managers Association, Paravore, Kollam, Kerala filed a Civil Writ Petition W.P.(C)-13450 of 2019 against the schedule of AITT under CTS, June' 2019 in Hon'ble High Court of Kerala at Ernakulum with a prayer to direct the respondent to postpone the exam of AITT under CTS (Annual Examination) of 2019 till the completion of the syllabus. The Hon'ble High Court of Kerala vide his order dated 10.05.2019 has directed to take up, consider and pass appropriate order at the earliest with in a period of one month from the date of receipt of a copy of judgment.

A representation of Karnataka Skill Development Pvt. ITIs Management Association dated 11.03.2019 was also received through Govt. of Karnataka on dated 23.03.2019, alongwith representation of Karnataka State Pvt. ITI Management Association, Prantiya Pvt. ITI Owner's Welfare Association, ITI Mahasangh Gwalior, Madhya Pradesh, Andhra Pradesh State Pvt. ITI Managements Association and Telangana Pvt. ITI Managements Association for postponement of the said exam till completion of DGT syllabus and to reschedule in July, 2019. Similar representation was also from State Pvt. ITI Association, Odisha received at DGT to postpone the exam due to disruption of training activity by Natural Calamity in the state of Odisha.

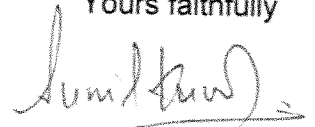
In compliance to the order of Hon'ble High Court of Kerala at Ernakulum dated 10.05.2019 and considering the above mentioned representations, the competent authority has decided to postpone the exam of AITT under CTS (Semester System, Dual System and Annual Examination) and it will be held from 01.07.2019 onwards as per attached schedule.

Due to time limitations for generation of fresh hall tickets with new dates, the hall tickets generated from NCVT MIS Portal for AITT commencing on 10.06.2019 will be valid for corresponding examinations i.e. Old date Vs. New dates.

It is also informed that the examination of COPA trade will also be conducted offline i.e. OMR based. The requirement of OMR and question paper should be submitted to TT Cell, DGT at the earliest possible.

In view of the above, the Principal of all the ITIs under your control may be advised to communicate this decision to all trainees and to ensure that the syllabus should be completed before commencement of examinations by arranging extra classes, if required. Also NCVT MIS Portal generated hall tickets to be provided to every eligible trainees. Trainees without proper NCVT MIS Portal generated hall ticket are not eligible to appear in AITT under CTS.
